10. STABILITY AND REACTIVITY

Stable under the recommended storage and handling conditions (see Section 7). In a fire, hazardous decomposition products such as smoke, carbon monoxide, carbon dioxide, and oxides of nitrogen may be produced. I. TOXICOLOGICAL INFORMATION

There is no data available on the product itself. The product has been assessed following the conventional method in CHIP and is classified for toxicological hazards accordingly. This takes into account, where known, delayed and immediate effects and also chronic effects of components from short-tern and long-tern exposure by oral, inhalation and dermal routes of exposure and eye contact. Animal studies have shown that some insoluble chromates are carcinogenic but the data does not extend to lead chromate pigments. There is no evidence of a risk of lung cancer arising from the use of lead chromate containing products. Epidemiological data shows an association between elevated maternal blood lead levels and developmental effects in the offspring. Following the introduction of the criteria for Toxic to Reproduction hazard classification the EC has classified all lead compounds as causing developmental toxicity in humans. Lead chromate, although of relatively low solubility and bloavailability, is included in this classification.
