# 4. FIRST AID MEASURES

### **GENERAL**:

# EXTINGUISHING MEDIA:

Recommended:- Alcohol-resistant foam, CO2, powder, water spray/mist.

### RECOMMENDATIONS:

Fire will produce dense black smoke containing hazardous products of combustion (see Section 10). Decomposition products may be a hazard to health. # 6.ACCIDENTAL RELEASE MEASURES.

### HANDLING:

Additionally, the product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard. Keep the container tightly closed. Exclude sources of heat, sparks and open flame. Non sparking tools should be used. Avoid skin and eye contact. Avoid inhalation of vapour (and spray mist). Smoking, eating and drinking should be prohibited in areas of storage and use. For Personal protection, See section 8.
